WHEREAS, recognition was granted by the Northern Regional Committee to Geeta Arya College of Education, Julana, Distt.- Jind, Haryana vide Order No. F. NRC/NCTE/HR-1447/171st Meeting/2010/603 dated 18th November, 2010 for conducting B.Ed. Course with an annual intake of 100 students followed by Revised Recognition order No. NRC/NCTE/HR- Common orders/2015/117661-68 dated 30<sup>th</sup> June, 2015 for annual intake of two units of 50 students each.

AND, WHEREAS the institution submitted an application on 08.08.2018 for shifting of premises from Julana, Distt.- Jind, Haryana to Khasara/Plot No.-48, Killa No.-7/2, 14, 15/2, Street No.-5 K.M, Milestone Julana, Jind Road, Village-Jai Jaiwani, Post Office/ Tehsil/Taluka-Julana, District-Jind-126101, State-Haryana.

AND, WHEREAS, the matter was placed before the NRC in its 288th meeting held from 5th to 7th September, 2018 and the Committee decided that VT be constituted for shifting of the institution at new premises. The inspection was conducted on 21<sup>st</sup> & 22<sup>nd</sup> December, 2018.

AND, WHEREAS, The matter was considered by the NRC in its 295th meeting held on 6th -11th February, 2019 and the Committee, decided to issue Show Cause Notice under section 14 (3)(b) of the NCTE Act, 1993 giving specified time for submission of reply on the following grounds:-

1. Total built-up area as per VT report is only 1504.60 Sq. Mts. for two units of B.Ed. against the requirement of 2000 Sq. Mts. as per NCTE Regulations 2014.

AND, WHEREAS, the matter was considered by the NRC in its 301st meeting held from 9th to 11th May, 2019 and the Committee decided Shifting of premises is permitted as requested by the institution.

AND, NOW, therefore, the Northern Regional Committee hereby grants permission to to Geeta Arya College of Education, Julana, Distt.- Jind, Haryana for shifting of premises from Julana, Distt.- Jind, Haryana to Khasara/Plot No.-48, Killa No.-7/2, 14, 15/2, Street No.-5 K.M, Milestone Julana, Jind Road, Village-Jai Jaiwani, Post Office/ Tehsil/Taluka-Julana, District-Jind-126101, State-Haryana under clause 8 (9) of the NCTE Regulations, 2014 for conducting B.Ed. course with an annual take of two units of 50 students each.
